The Blue Cordon is a concept for a Pan-African network of Regional Monitoring, Control, and Surveillance Centers protecting Africa's fisheries and blue economy resources. It strengthens inter-regional cooperation to tackle IUU fishing and offers practical solutions by reinforcing collaboration and communication, addressing many of the overarching challenges of our time including:

An up-to-date record of the current bestknown identities and operations of all vessels that currently appear on lists of recognised IUU fishing vessels maintained by Regional Fisheries Management Organisations. www.iuu-vessels.org



### **Fisheries Analytical Capacity Tool (FACT)**

TMT holds the world's largest active repository of data and analysis on industrial fishing and related vessels, their current and recent identities, operational and compliance histories, and relationships to companies and other entities.



Vessel Viewer is an innovative vessel history and insights tool codeveloped by TMT and Global Fishing Watch. The tool arms authorities with the information needed to make a rapid assessment of a fishing vessel and its recent operations
